Hey Babe,

Late last night I was finally given your letter post marked 7/4, after asking a CO to look for it. The Order of Robert Larsen is yet another example of his total disregard for the law. Of course I am not allowed to petition the court in violation of the 1<sup>st</sup> Amendment and we know Anita Burns is not acting in my defense, she is a puppet of the prosecution.

I believe Robert Larsen has become serial and delusional. Believing he is not required to provide due process of law in accordance with the 5<sup>th</sup> Amendment. Of course the whole case is based upon fraud, with a rubber stamped indictment now soon a rubber stamped mental incompetency determination. Based upon others knowledge Jeremiah Dwyer is the Judges' hatchet man, anyone a Judge wants incompetent Dwyer determines them incompetent. Regardless of what the true competency of the individual may be.
