My Fellow Americans,

On March 1, 2012, I learned the "Supreme Court of the united States", has reviewed the "Petition. for Writ of Certiorari" and they are going to hear the case. Staff Counsel has reviewed the Petition and it has already passed preliminary examination by a panel of Supreme Court Justices. The Justices have ordered the Clerk to docket the case (11-9146) and send notices to the "UNITED STATES DISTRICT COURT FOR THE WESTERN DISTRICT OF MISSOURI and the "8th CIRCUIT COURT OF APPEALS". We were informed these notices would order these courts to send all case files, transcripts and recordings of proceedings to the Supreme Court for review. The Clerk has repeatedly praised the Certiorari as one of the best he has seen. I wish I could say it was all me but that is not true. The Certiorari was put together from information collected from "Americans" all across this great nation, who share in this achievement. We were informed the Supreme Court receives about 200,000 Certiorari (s) per year and only hear about one percent or 2,000. In this situation, I believe, we have finally been heard.

This opens up a whole new can of worms for those in our Courts who have violated law, denied due process and conspired against rights. The Court's records will clearly show that I acted within the Federal Rules of Procedure and was repeatedly denied the due process I was entitled to receive. The Court's transcripts will show that I repeatedly challenged the jurisdiction of the Court and the Magistrates and Judges repeatedly denied my right to this protection of Law. The record will speak for itself. A blind man could see the corruption in this case. But we have not won yet. The question I ask is, "Will the

"Officers of the Court" who have violated our law be held accountable?" Of course the first step is getting the case heard and then accountability determined. I must admit, I did not believe I had a snow ball's chance in hell of this case being heard in the Supreme Court. But I did have the faith of a mustard seed and prayed for an honest man to help me in this case. I believe God has answered my prayer, yet again, by touching the hearts of those Supreme Court Justices who reviewed the Certiorari and seen merit in its facts, law and evidence.

This case has the potential to stop the wide spread corruption, operating in our courts, under the color of law. No Federal Court has authority to hear any case where no injured party with standing has signed a complaint. Corporate employees of the FBI, DEA, ATF, IRS, etc... have no authority or right as an injured party and all cases brought by them are clearly fraud and perjury. Our Federal government has but one purpose and that is to protect the rights and property of the American People. Without one of us coming forward signing a complaint saying we have been injured the federal government has no authority to act. By the Supreme Court hearing this case, where I have been injured by beinging kidnapped, tortured, terrorized and persecuted, without a complaint, I must ask will the Corporate employees be held accountable or is this just another attempt to make the people fraudulently believe our government protects us. Our Supreme Court is, I believe, God's highest Court in this land and responsible to the American People to serve and protect each and everyone of us. I also believe until this case the Justices had little Knowledge of the crimes being conducted by the District and Circuit Courts. With power comes the responsibility to do good and with Knowledge comes the duty to act.

I pray that this case will re-establish the rights, privileges and immunities of the American People and remove the threat of scribes to bond us as slaves. I have lived almost 3 years in the company of some of the worst of our world and know there is clearly a need for prisons in our society. But the worst, I have seen are in our courtrooms, they are "liars" who bare false witness against the people. My Bible tells me in Deuteronomy 5:20, "You shall not bear false witness against your neighbor." God's law is clear and just in Deuteronomy 19:16-21 as follows:

16. If a false witness rises against any man to testify against him of wrongdoing.

17. then both men in the controversy shall stand before the LORD, before the priests and the judges who serve in those days.

18. And the judges shall make careful inquiry and indeed, if the witness is a false witness, who

has testified falsely against his brother.

19. then you shall do to him as he thought to have done to his brother: so you shall put away the evil from among you.

20. And those who remain shall hear and fear and hereafter they shall not again commit such evil among you.

21. Your eye shall not pity; life shall be for life, eye for eye, tooth for tooth, hand for hand, foot for foot.

In my case, "Officers of the Court" and their government conspirators, circulated false reports fraudulently claiming I caused injuries to my fellow man. Yet a trial of the evidence showed no-one I injured. I believe this to be false witness against me. These "liars" have succeeded in having me sentenced to 10 years in prison thus taking my liberty without just cause. I believe these "liars" should suffer the same fate, they have imposed upon me:

God's law goes on to condemn the government in this case, Deuteronomy 24:7, "If a man is found Kidnapping any of his brethren of the children of Israel, and mistreats him or sells him, then that Kid napper shall die; and you shall put away the evil from among you." In this case without an injured party of standing, I have been imprisoned almost Zyears. Magistrate Robert Larsen Kidnappeel me and subjected me to about 180 days of solitary confinement, with no phone, no mail and no visitation allowed. This is clearly cruel and unusual punishment without evidence of a crime thus clear violating the 1st, 4th, 5th, 6th, 8th and 13th Amendments of our Constitution. I have been sold into "involuntary servitude" (slavery) by the scribes (Attorneys/Judges) to the I.R.S. through their "GSA" bid bond, performance bond and payment bond system. I have petitioned for removal of this uhlawful lean upon the "person" and release of my property (my body) but to date the I.R.S. has refused. I have been beaten within an inch of my life suffering a broken nose, broken jaw and cracked eye socket while in the custody of the "FEDERAL BUREAU OF PRISONS" (BOP) under orders from United States Marshals. This persecution began on May 10, 2010 and continues to date. I have no power to stop these trespassers, they have all the guns, and have repeatedly refused my pleas for assistance. I pray to God I will survive until I am released by some government authority willing to lawfully perform their job.

If those within our government can commit these crimes against me, who God has graced with an understanding of law, what can this government do to those who have no knowledge of law? The answer is anything they want. Our government is no longer just, it is made up of tyrants who find pleasure in hurting others, whether it be a minor traffic ticket or murder all are subjected to scribes'

wroth. These are the facts that exist in case files and transcripts. Will the Crimes against me be punished or swept under the rug? Time will tell it always does. Will justice be served or will the trespossers be spared punishment for their crimes? The government is quick to inflict maximum penalties upon the people to show they are tough on crime, but ever so slow to inflict that punishment upon one of their own. "Conspiracy against rights" and "Kidnapping" carry the "Death Penalty". If our Judges were shown just once a violation of our Constitution carries cleath, no other judge would violate it again. It is one thing to persecute the people when you know you will not be held accountable. It is quite another to persecute the people Knowing if you are caught the penalty is death. Of course there is one standard for the people (maximum punishment) and yet another for scribes (no punishment). We all Know this fact of life.

LORD help me, because my life is in the hands of scribes. Many believe our government is just and fair and others believe they are corrupt and tyrants. But one thing we can all agree upon is our fate is at the mercy of the "B.A.R. Association". The B.A.R. has control of our "Judicial System" and the people are ignored in their courts. We all know unless you are a lawyer, and member of the "B.A.R." judges always rule against you. It is as true today as it was in Jesus Christ's day, "scribes interpretation of law is more important than what is written." It is no longer what the law says, it is who says what the law says. Scribes are always right in our courts today and the people are always wrong. This has been my experience since 1991 and I hope I am proven wrong by the supreme Court ruling in my favor. I would be the first to admit, there are some honest series scribes after all, but you must climb to the top to find them.

On March 1, 2012, the 8th CIRCUIT COURT OF APPEALS granted me the right to proceed in Forma Pauperis and denied me the right to counsel. The WESTERN DISTRICT ruled I could not proceed in Forma Pauperis thus denying me the right to appeal and obtain the transcripts and legal file that Show the crimes of the "Officers of the Court". Now the 8th CIRCUIT says they must produce these records without casts to me. By being incarcerated, with no source of income the WESTERN DISTRICT tried yet again to deny me due process of law required by the 5th Amendment. I am preparing 3 motions for the court of appeals the first, "Demand for Sixth Amendment Appointment of Counsel", the second, "Demand for Appeal Bond and Release" and third, "Demand for Determination of Void Judgment." The last could allow the Court of Appeals to excape the unpopular requirement to rule the jurisdiction of the WESTERN DISTRICT. The Supreme Court must determine that issue.

We must depend upon scribes to perform the "Public Service" of fair and impartial determination of the Cases presented to them. Today could be a turning point in our history, where the common practice of refusing the law presented by the people is no longer allowed, the law determines the case not who presents the law. I am so thankful God has blessed me over and over again with the chance to serve and help the people. I can only hope God will touch the hearts of our Supreme Court Justices and compel them to act in this cause to end the rain of terror beinging inflicted by Corporate America upon the American People. I am the first to support common law that says if you injure one of the people or damage their property, you should be punished for your crime. All members of government, including scribes, should be accountable to this law just like each and every one of us.

I have set a pretty high goal for myself to change our "Justice System" to a fair and just _ system we can all be proud of and support. The first step is making the lawful requirement of an injured party who has standing be present in every case is essential. This act allone would reduce the number of inmates by 80% because Assistant United States Attorney, conspiring with DEA, ATF, FBI, IRE, etch could no longer fabricate cases based upon unlawful complaints. The American People are all entitled to common law that says if I do not hurt anyone or damage their property, I have committed no crime. Scribes have come to fraudulently claim to represent the "UNITED STATES OF AMERICA" a corporate fiction. The "Common Law" of "Agency" says the "Principal" must appear and state the authority of the "Agent" to represent its interest. Everyone Knows the "UNITED STATES OF AMERICA" can not appear, therefore no attorney can represent it. The law is clear, "He who fails to state his rights, has none." Since the corporate "UNITED STATES OF AMERICA" can not speak, it has no rights in our Courts of Justice. This common sense has been abandoned by scribes who wish us to believe they are just in their conduct. In God I trust, all others must prove they are justified in their conduct, especially scribes.

I pray to God, to send wisdom to our Supreme Court Justices to stop the abuse, persecution and terrorism by scribes against the American People. I pray the Supreme Court will hold those accountable who have violated me and prosecute their crimes. I believe the Supreme Court should send a message to every lawyer and judge, abuses of the People will no longer be tolerated. After all it is the principles of our Constitution, that each and every member of the Supreme Court has sworn an Outh of Office to support.
