"Affidavit of Denny R. Hardin, Agent"

"Final Notice"

I, Denny Ray Hardin, am an "American Citizen", not a "UNITED STATES CITIZEN". I am a "Private Banker" operating the "Business of Banking" in "Honor" in "Commerce". This fact has been presented, by "NOTICE AND DEMAND", throughout the "Financial Industry" and not lawfully "Dishonored" to date, by any bank or government authority. Many "Complaints" and "Requests for Investigation" have been filed with the "Federal Trade Commission", responsible for enforcement of all securities, 15 USC 1692 I (Small "L"). Some have been forwarded to the "Comptroller of the Currency". Because these "Government Agencies" have failed to perform as lawfully required, a "Criminal Complaint", was filed with the "Judge Advocate General" who refused "Admiralty Jurisdiction" to prosecute these crimes, suggesting I work out this problem with these government agencies. The "Universal Postal Union" (UPU) [USPS Tracking RB 666 190 916 US] has received this "Criminal Complaint" in case this government fails to enforce the UCC Regulations, this matter will be taken to the "Hague Convention" for violations of "International Law". The message is simple, "Do your job and enforce the law, or you are part of the problem that must be dealt with. You will be held accountable".

Within the law of "Commerce" any fact presented by "Affidavit" not disputed within 30 days is admitted as an "Unrebutted Affidavit". Based upon this law, every "Commercial Instrument" ledgered by the "Private Bank of Denny R. Hardin" is a "Negotiable Instrument" issued to satisfy a certain account for which it was issued. Failure of all banks, all mortgage companies and all lending institutions to accept the lawful currency for the payment of debt is a violation of HJR 192. All have failed to lawfully "dishonor" the "Bonded Promissory Notes" as required by UCC3-503. All have refused full payment for the debt and the debts are paid in full UCC3-603. A large percentage of the 450+ accounts have not been credited and the financial institution's records are in error. The attached "Criminal Complaint" is currently filed with the "Judge Advocate General" in his "Admiralty Jurisdiction" 28 USC 1333. It has not been refused. The list of defendants who have refused the law of commerce and are interfering with its functions, is presented

to you to determine which of these "Defendants" are within the scope of your "jurisdiction". When all the defendants have credited the accounts, as required by law, relinquished the obligations of my "Principals" and will comply with the law of commerce, then this "Complaint" will be removed. Until then all "Defendants" are in "dishonor" for engaging in "Organized Crime".

Upon written request of the "government agency", a list of my Principals, with their account numbers will be provided for investigators. When written confirmation is received that all accounts of a "financial institution" have been credited and the obligations removed, that institution will be removed from the list of Defendants. When all defendants are removed through lawful action, a voluntary dismissal will be presented. Until then this case stands as an "Indictment" of the "Financial Industry" of "America". This is a "Nonnegotiable" contract with my representatives in all "government" agencies served by Certified Mail in accordance with the list provided by the "FEDERAL TRADE COMMISSION" attached, refusal to act as required by law will constitute "willful neglect of duty" to enforce the law of commerce.

I, Denny Ray Hardin, declare under the penalty of perjury, under the laws of the United States of America that the foregoing is true and correct to the best of my knowledge and beliefs. This Affidavit is made without purpose of evasion or intent to mislead, if some fact is proved by facts, law and evidence to be incorrect, I reserve the right to amend for the truth to be clearly stated. "Truth" is the law of "Commerce". "Judgment" must follow the "Truth". This "Affidavit" can only be "dishonored" by "Counter Affidavit" signed under the penalty of perjury, disproving each and every sentence. I stand in "honor" as an "American Citizen".
