## "The Mental Incompetency of Government"

I believe, as do the majority of the American People, that our government has become incompetent. Government employees, whether state or federal, whether civil or judicial, are required to have an "Oath of Office" to support our Constitutions. This lawful requirement has become a mere formality before taking public office and the majority of public servants violate their "Oath of Office" on a daily basis. Most "Public Servants" have come to believe the "Public Office" is their personal domain, when in truth every "Public Office" is a position of public trust, that has strict guidelines for its operation. The majority of the "Public Servants" in America today have not even read the Constitution they have sworn to uphold. The "Constitution for the United States of America" is a "contract" between the American People and Public Servants that clearly states the Powers and limitations of Government. Ignorance of the "Supreme Law of the Land" as stated in Article VI is no defense for the ~~"Mental Incompetency"~~ of a "Public Servant".

When a "Public Servant" refuses, fails or ignores the guidelines set forth in the Constitution, a crime is committed. This crime is "Insurrection or Rebellion" 18 USC 2383. This crime is present in almost every court house, in almost every court room, by almost every Judge both state and federal, in America today. Judges and attorneys have come to believe they are the law and have established a "common practice" of ignoring all law in their offices of Public trust. This "Common practice" has become

a set standard of every "BAR" (British Accredited Registry) Association in America today. Of course this is a crime, known as "Seditious Conspiracy" 18 USC 2384. When an Association of Foreign Agents 22 USC 611 openly and actively oppose our Constitution and laws these acts are clearly "Treason" 18 USC 2381. This is the current state of our "Judicial System" in America today. The 13th Amendment of the Constitution for the United States of America, ratified by Congress in 1819, was meant to protect us from these "foreign agents" by refusing them access to any of our "Public Offices" of trust or profit. The 13th Amendment stood as law for over 50 years, until a "Foreign Agent" took the position of President and unlawfully removed it from our Constitution. The BAR member was Abraham Lincoln. The first act of this President was to disband our Constitutional Congress, suspend Habeas Corpus and removed the 13th Amendment. After the "Civil War", the new 13th Amendment freeing the slaves was incorporated. Our Constitutional Congress was never reassembled, the President was assassinated, before he could do it. Therefore, based upon these facts there is no lawful Congress in the United States of America today. A "Corporate Congress" made up of mostly "Foreign Agents" has operated without our Constitution since the "Civil War". This alone is the reason for the down fall of our nation, Foreign agents have abolished our Constitution in favor of their monopoly of our laws.

I believe the biggest down fall of our Judicial System is the suspension of Habeas Corpus because the courts are allowed to ignore the pleas of an unlawfully incarcerated man. While incarcerated in the State of Missouri I filed 14 Habeas Corpus

to courts across the United States of America. These included the United States Supreme Court, the United States Superior Court, the Missouri Supreme Court, the Jackson County Circuit Court and the Randolph County Circuit Court within the rules set forth for filing Habeas Corpus and not one court would grant it. Since I have been incarcerated in the Federal prison for 69 days I filed Habeas Corpus in the United States District Court for the Western District of Missouri who has refused to file it. I presented all these courts with Habeas Corpus under Article 1, Section 9 of our Constitution just to have it ignored by "foreign Agents" unlawfully holding the "Public Offices" of Judge. I believe these acts constitute "Conspiracy against right" 18 USC 241 and "Deprivation of Rights under the color of law" 18 USC 242 and clear "Willful neglect of duty" 18 USC 3332. Because this "Common Practice" is present in all courts named above I believe this is "Seditious Conspiracy" 18 USC 2384 of "Treason" 18 USC 2381 by all judges of these courts.

I do not believe our current Judicial System can be saved because every judge has corrupted his "Public Office" by taking it as a foreign agent. I believe we must remove every Foreign Agent from every Public office in America. No BAR member should be paid American Tax Dollars to represent the "British interest" in our courts. The only way I see to restore justice in America is to abolish all BAR Associations. BAR Association members have been allowed to terrorize, persecute, abuse and fleece the American People for far too long. Either government will end this rain of terror or the American People will have no choice but to take matters into their own hands to protect themselves and their posterity.

Because our Congress (Representatives & Senators) is made up of mostly "Foreign Agents" we need to abolish all BAR Associations or remove them from our "Public Offices". When our law makers are made up of those who profit from the laws then it is their interest being served and not the interests of the American People. The "Corporate" "UNITED STATES OF AMERICA" must be abolished and our lawful "Constitutional" "United States of America" must be restored. The lawful "Constitution for the United States of America" ended with the 13<sup>th</sup> Amendment, ratified in 1819, all amendments since are "corporate amendments" and unconstitutional. Only when lawful government is restored to the American People, can the "United States of America" be restored to its former glory. We defeated the British in the "American Revolutionary War" and again in the "War of 1812", if necessary I believe we can defeat them again in this generation.

While the "foreign agent" Obama thinks "Health Care" and "Financial Reform" are the number one priority, I believe "Judicial Reform" should be next to stop the hatred brewing against government officials by the American People. When we are subject to the criminal acts of Foreign agents and denied our rights, privileges and immunities by corrupt government officials sworn to serve us, the time has come for action, by government or the American people, I believe the Restore America Plan has great potential for a peaceful Solution. As a pacifist I sincerely hope it works.
