

Where do we go from here?

As I sit in this prison cell of mine, I feel lost, abandoned, betrayed, humiliated and discouraged. But I know I am not alone in these feelings they are shared by the majority of the American People. Today in America we have stopped dreaming, because every dream is met with adversity by government, banks, courts, judges, lawyers and politicians. If we are not a Corporation, we have no possibility of success, because only Corporations are allowed to prosper in our nation. A Corporation can lobby our representatives and receive full support from government who will spend trillions to make a bad idea work, but won't invest and won't support any American to prosper, Only Corporations have the ear of our government the rest of us are left out. I want to succeed, prosper, participate, contribute and bring about change for the improvement of our nation. But I am not allowed to claim my peice of the American Dream.

I sit in prison, because I exercised my 1<sup>st</sup> Amendment right of freedom of speech and said "I will abolish the Court". A corrupt court, operated by dishonorable men who steal from Americans daily for the profit of a Corporation known as "KANSAS CITY, MISSOURI". "Organized Crime" operated by "foreign agents" to "extort" money from the poor, under the threat of incarceration if one refuses to pay. Likewise, the "JACKSON COUNTY CIRCUIT COURT" can violate an American Citizen's 1<sup>st</sup>, 4<sup>th</sup>, 5<sup>th</sup>, 6<sup>th</sup>, 9<sup>th</sup>, and 11<sup>th</sup> Amendment rights, deny him due process of law, take his liberty and freedom, and this is acceptable behavior. All of these "Public Officials" have one thing in common they are all members of the [BAR] (AKA "BRITISH ACCREDITED REGISTRY"). [BAR] members allow [BAR] members to break our law and protect each other from criminal prosecution. My case proves "Treason", "Seditious Conspiracy", "Conspiracy to overthrow government" and "Misprison of felony", but since there is no court, not controlled by [BAR] members, there is no possibility of prosecuting their crimes. [BAR] members get great interest rates Americans do not. [BAR] members can break the law and not be prosecuted Americans can not. Americans go to prison without due process of law [BAR] members don't go to prison for the crimes they commit. Americans who voice their opinions of [BAR] members are made criminals. [BAR] members are paid to protect our rights but only the rich are protected, all others are railroaded. Our forefathers anticipated this day would come and the last Constitutional 13<sup>th</sup> Amendment passed by our lawful Congress in 1819 prohibited all [BAR] members from holding any Public Office of trust or profit.
