

By Denny-Ray: Harden Bonded Slave

Dear Fellow Americans,

On February 2, 2012, I was sentenced to 10 years in prison, by Judge Gary A. Fenner, of the "UNITED STATES DISTRICT COURT FOR THE WESTERN DISTRICT OF MISSOURI". I filed a "Petition for Writ of Prohibition" to the "8th CIRCUIT COURT OF APPEALS", challenging Fenner for proceeding to a trial of the merits without jurisdiction being stated for the record. As you well know, this was denied. The denial clearly establishes acts of treason by the 8th CIRCUIT and WESTERN DISTRICT who are "Warring upon our Constitution" a crime under 18 U.S.C. 1918. A "Petition for Writ of Certiorari" was delivered to the "Supreme Court for the United States" for the second time, on February 1, 2012, to address these issues. To date the "CLERK OF THE COURT" has refused all petitions, denied access to the Justices and unlawfully made judicial determinations of our petitions. The actions of the CLERK to obstruct justice is clearly aiding and abetting the treason of the 8th CIRCUIT and WESTERN DISTRICT allowing the crimes to continue.

When I began this fight, I prayed to God to let the truth be known. I believe God is answering my prayer and the truth is becoming crystal clear. In our Courts today, there is no law, there is no justice or due process. Look at all the laws presented in this case and not one of these laws were enforced by the Judges who have sworn an oath to uphold them. Our Courts no longer protect the rights of the People or concern themselves with facts, law or evidence, all are guilty and sent to prison as "Bonded Slaves" of the "B.A.R.". Today the Federal Government pays "B.A.R." members salaries plus benefits, from tax payers' money to fill corporate prisons for the profit of corruption. "B.A.R." members have overthrown our courts, that are supposed to be

"Public Institutions", to operate as "Extortion Operations", in clear "Racketeering" by "Interference with Commerce by threats and force" prohibited by RICO 18 U.S.C. 1951, for the profit of "B.A.R." members. The question today is not whether or not you have broken the law, but whether "B.A.R." members can profit by putting you in prison. Our law has become "mean spirited" for "scribes" (attorneys) and "scribes" (Judges) to inflict cruel and unusual punishment upon the People who refuse to bow to their superiority. Our Courts have become our oppressors, persecutors and terrorist who violate, abuse and enslave the People for the profit of 'scribes'. Jesus Christ condemned "Scribes/Lawyers" in Luke 11:46 for their burdens upon the People. It was as true in His day, as it is today. Why should we pay "scribes"?

No-one has signed a complaint against me, yet I am in prison for 10 years without due process of law. I must sit in prison while "scribes" of the 8th CIRCUIT and SUPREME COURT decide to enforce the law they created that dictates their conduct. These "scribes" have been known to take years to decide a case that should have been dismissed immediately. In our Courts there is no accountability among the "scribes". They all can engage in criminal conduct unpunished that would put one of us in prison for life. For example: our "bankers/sadducees" who have stolen Billions for their profit and now must pay a small percentage of those profits to the People they have stolen from. Bank Fraud, Mortgage Fraud, Racketeering and Theft are now acceptable conduct for sadducees (bankers). I ask, "Do the People who have been violated think a check for \$1,500.⁰⁰ is worth losing their house to bankers? Our government has become a threat to the liberties our forefathers fought and died to give us. Only "scribes/sadducees" are protected from prosecution and have become the law breakers of our society. Where can the People go to prosecute the crimes of

"scribes"? The answer is no where. Every government office that prosecutes crime, refuses all case against "Lawyers/scribes" "sadducees/bankers". Jesus Christ has condemned them all and we should too.

Today it is "common practice" for defense attorneys (scribes) to threaten their clients into signing a "Plea Agreement" rather than going to trial. For example: one of the People is caught with someone who has drugs on them. Though he did not know about the drugs, on them, he is arrested and charged with "Conspiracy" and now faces 10 years to life in Federal Prison. Then his defense attorney "scribe" tells him to sign a "plea agreement" for 10 years or face life in prison if he goes to trial. Know you are innocent, what would you do? This "Racketeering Activity" of "scribes" results in 90% of the Federal prisoners pleading guilty. "Scribes" in the position of Judge, Prosecutor and Defense Attorney, work together to "Extort" guilty pleas by threatening, coercing and terrorizing the People into submission to their unlawful claims of criminal conduct. Thus the People goes to prison and the "scribes" profit by "Bonding Slaves". Every person, who goes to prison is bonded for the profit of "scribes" operating slavery in violation of the current 13th Amendment. "Slavery" is common in all Courts of the UNITED STATES OF AMERICA, INC..

The law is clear, the Supreme Court has clearly established that an "injured party" with "standing" must sign a "complaint" to activate the power of the Federal Courts. The corrupt "DEPARTMENT OF JUSTICE" utilizes corporate employees of the DEA, ATF, FBI, IRS, etc... who fraudulently sign complaints. These corporate employees are paid salary plus benefits from tax payers' money to keep "scribes" (ASSISTANT UNITED STATES ATTORNEYS and FEDERAL PUBLIC DEFENDERS) supplied with cases. Every case where the "UNITED STATES OF AMERICA" is "Plaintiff" is clearly denial of due process

of law in violation of the 5th Amendment, because the Defendant is denied the right to cross examine his accuser. "Scribes" have made violations of Constitutional rights "Common Practice". Every criminal case should read "The People of the United States of America and John Doe" Plaintiffs vs "John Doe" Defendant. By elimination of the physical plaintiff, "scribes" have made it acceptable to prosecute without an "Injured Party". For example: In Kansas, "Ghost Drugs" are the "Common Practice", though no drugs are presented, corporate employees fraudulently posing as law enforcement agents, sign a "complaint" in perjury saying the Defendant sold an ounce of drugs per week for two years, thus 108 ounces, that carries a penalty of life in prison. No evidence, no injured party, just an "agent" meeting his quota to provide "scribes" with cases for their profit. Then comes the "scribes" (Defense Attorneys) who say sign this "Plea Agreement" for 15 years, if you go to trial you will get life. And "scribes" (Judges) back up their threats by giving the maximum to those who go to trial, to detour others from seeking their rights in Court. Federal Prisons are full of people with these horror stories, all are Americans deprived of their rights and due process of law. With all the laws shown on this website, that requires my release, no law of the "scribes" justifying my incarceration, yet I sit in prison. Is this Justice? Do the American People condone this criminal conduct of their Public Officials? Our government, controlled by "scribes" has become the largest gang in America and is clearly the leader of "Organized Crime" of "Racketeering", "Slavery", "Extortion", "Money Laundering" and "Treason", for the profit of the "B.A.R.". When "scribes" can "Kidnap" one of the People, throw them in prison for years without trial or due process of law, something is clearly wrong in our government. Why should we pay corporate employees of the FBI, DEA, ATF, IRS, etc., to entrap Americans for "scribes" profit?

As an "Injured Party" harmed by the criminal conduct of "scribes" where can I go for prosecution? I have tried the "District Court of the United States", denied! I have tried the "8th Circuit Court of Appeals", denied! I have tried the "Supreme Court for the United States", denied! I have tried the President, denied! I have tried the House of Representatives, denied! I have tried the United States Senate, denied! I have tried the Attorney General, denied! I have tried the Secretary of State, denied! I have tried the Homeland Security, denied! I have tried the Judge Advocate General "JAG", denied! All these "Public Offices" who have sworn an oath to support our Constitution and laws of the United States, but all refuse to perform their lawful duties. What we, the American People, fail to realize is every one of these "Public Offices" are controlled by "Scribes". They have succeeded in removing the original 13th Amendment from our Constitution that prohibits them "scribes" to hold any "Public Office" of trust or profit and are working in concert to steal America from the People.

I believe this to be an "Organized Plot" to destroy America. Consider, bankers take money out of circulation to cut small business employment. Corporations sit on Billions to increase unemployment to force the People to accept less for their labor while increasing the cost of living for corporate profits. "Scribes" (Attorneys and Judges) work with "Sadducees" (Bankers) to steal properties (Foreclosures) from the people who can no longer afford to pay their inflated mortgages. Now the bankers and scribes own these properties that they can resell or rent out for their profit. The "scribes" believe they have finally achieved the power to establish their "New World Order" with "scribes" as the "Ruling Class" and all the rest of us as their "Slaves". Police, Military, Courts, Banks, Government,

Corporations, etc... all controlled by "scribes/sadducees" against the People who pay their salaries. Why can't we prosecute bankers who steal, commit fraud and profit by crime? Why can't we prosecute "scribes" who "Kidnap" us and hold us hostage without due process of law? Why can't we prosecute Judges (scribes) who act without jurisdiction to violate the Peoples' rights? The answer is simple, "scribes" say we can not. Their criminal conduct is protected by police, by Courts and by government who say no-one has the right to hold "scribes" accountable. Those paid salaries plus benefits, by the People to "serve and protect" are ignorant of law and must rely upon the "scribes" to tell them what law to enforce. Law enforcement has become "scribes" muscle to enforce their "Organized Crimes". Evicting People from their homes, stealing their property and generating cases for "scribes" profits are today's law enforcement's duties. Jesus Christ in Luke 11:52 said, "Woe to you Lawyers! For you have taken away the key of Knowledge. You did not enter in yourselves and those who were entering in you hindered."

So I ask the question, "Why won't our Judges enforce the rights, rules, precedence and law created by them? Consider my efforts below.

2. 8th Circuit Court of Appeals
 - A. Writ of Mandamus (Denied Twice by Clerk)
 - B. Writ of Habeas Corpus (Denied Twice by Clerk)
 - C. Writ of Prohibition (Denied by Clerk)
 - D. Notice of Appeal (Pending)
3. Western District of Missouri
 - A. Jurisdictional Challenges (Ignored twice)

B. Order to Void Judgment, Sentence and Commitment
(Pending in Western District / Exhibit 8th Circuit)

These are all present on this website for your inspection and not one of these, or the law they present, have been honored in any court. Is this just a case of discrimination against Denny Hardin? I think not, because the same conduct is present in cases all across America. There is no way to hold "Officers of our Courts" accountable and no source to petition for redress of grievances.

"Scribes" have corrupted every "Public Office" of our "Judicial System". This also holds true in our Executive and Legislative Branches where "scribes" maintain the controlling interest. As long as there is a "B.A.R." persecuting Americans, the People will never be free. This is the "Truth" God has shown me, let the "scribes" come forward and prove it is not so.

I say abolish all "B.A.R." Associations or remove all "scribes" from every Public Office in compliance with the original 13th Amendment. British loyalist of the "British Accredited Registry" have no right to enter our courts and violate our law. These Foreign agents are working in concert against the American People. To end this I believe Thomas Jefferson said it best, "Tyranny can only exist where honest men do nothing." Where are our honest men?

I have prayed for God to show me the truth and I believe God has answered my prayers. Now it is up to each and every American to do their part to see that our rights, to life, liberty and happiness are equally protected among us. Freedom must be restored in America or it is lost in our world. Every single American is given, by God, unalienable rights secured by our Constitution. If they violate one of us, they violate us all.
