2. FURTHER ADVISEMENT


This is to advise that all of the actions of the court and all others in these cases against Defendant are in violation of...



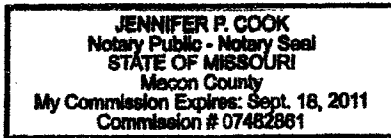

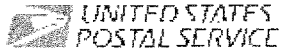
