**“Official Notification of Treason”**

Dear Sir;

It is with great shame, that I must inform you of the “Treason” , of the Missouri Supreme Court.

On November 23, 2023, I filed an “Original Petition for Damages” at the Supreme Court in Jefferson City, Missouri and paid the filing fees. To date the Missouri Supreme Court has refused to give the case a Case Number or docket the case for adjudication. Repeated efforts have been made to get the Missouri Supreme Court to perform its lawful duties, with no success.

I am ashamed to say the Missouri Supreme Court is aiding and abetting the Treason of UNITED STATES, INC. who is operating Article IV Legislative Courts of no jurisdiction or authority of law to conduct fraudulent judicial process.
